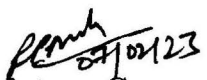

4. Final/Provisional Certificate and Marksheet/Transcript of LL.B. / LL.M,
5. Recommendation letter secured not older than 03 months of date of the advertisement,
6. Identity & Address Proof (Aadhar Card / Voter ID/ PAN Card/ Driving License/ Passport etc.),
7. Two recent passport size photographs, having white background,
8. N.O.C. from the present employer, if any.

The interview shall be of 10 marks and qualifying marks shall be 04 out of 10. However, the final result shall be prepared on the basis of consolidated marks obtained in the Written Test/Screening Test and Interview.

The candidates are advised to keep visiting the Court's website regularly for further details/updates.

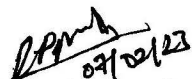

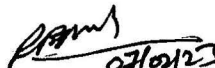
